- Time:** Set up 7:00-10:00 am. Show hours 10:00 am - 2:00 pm. *Absolutely no early packing!*
- Booths:** Approximately 10' x 9' (includes up to 2 tables and chairs, electricity provided) **\$120**  
Approximately 13' x 9' (includes up to 3 tables and chairs, electricity provided) **\$140**
- Display:** Tables must be covered; lighting suggested: limit 300 watts (use energy saving bulbs)
- Merchandise:** Bring fresh, quality antique/vintage merchandise. **Price all merchandise.**  
Promoter reserves the right to ask for removal of unsuitable items.
- Taxes:** Exhibitor is responsible for sales taxes or exemptions on sales. Maine state law requires Promoter to submit a list of dealers, including their addresses and Maine state sales tax numbers.
- Liabilities:** Exhibitor shall not hold the Promoter, Bath School Department responsible for any loss due to theft, damage, or injury to any person, goods or property caused by accident or negligence, willful or otherwise.
- Fees:** **\$120** per 10'x 9' or **\$140** per 13'x 9' booth (\$10 less if paid 4 or more weeks in advance). *If space is cancelled less than 48 hours before show, there will be a \$50 cancellation charge.* Please make checks payable to the show promoter, Paul Fuller.
- Note:** **Maine State law prohibits firearms, operational or not, inside school buildings!**
